11 WHEREAS, the Lake County Board of Commissioners hereby  
12 declares that public emergency exists with respect to the  
13 ability of Lake County to provide certain juvenile justice  
services;

14  
15 WHEREAS, the Lake County Board of Commissioners hereby  
16 declares its intent to enact this ordinance in order to ratify  
17 creation of the Central and Eastern Oregon Juvenile Justice  
18 Consortium (CEOJJC) by intergovernmental agreement with the  
19 counties of Baker, Crook, Deschutes, Gilliam, Grant, Harney,  
20 Jefferson, Hood River, Malheur, Morrow, Sherman, Umatilla,  
21 Union, Wallowa, Wasco, and Wheeler;

22 WHEREAS, the effective date of the intergovernmental  
23 agreement creating CEOJJC shall be upon adoption of this  
24 ordinance. The intergovernmental agreement was signed by the  
25 Lake County Board of Commissioners on February 21 1996;

26 WHEREAS, the purpose of the CEOJJC is to create a

1 management system which shall develop, deploy, and deliver  
2 juvenile justice services within Lake County and all of the  
3 other counties participating in the intergovernmental  
4 agreement. A copy of the intergovernmental agreement creating  
5 the CEOJJC, attached and incorporated herein by reference,  
6 more specifically sets forth the public purpose of the CEOJJC;

7 WHEREAS, the CEOJJC shall be vested with all of the  
8 powers, rights and duties to carry out its stated and intended  
9 functions, as described in the attached intergovernmental  
10 agreement.

11 NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF LAKE  
12 COUNTY, OREGON ORDAINS that, by virtue of this ordinance, the  
13 intergovernmental agreement creating the Central and Eastern  
Oregon Juvenile Justice Consortium is hereby ratified.
