- An additional \$500 legal fee will be charged on all approved loans. (May be included in loan amount.)
- Committee meetings will be scheduled as needed upon receipt and sufficient time to review new loan applications.
- The maximum loan amount is \$35,000. This limit may be exceeded under special circumstances.
- Adequate collateral is required on all loans.
- Additional information may be requested as deemed necessary.
- Loans considered for approval by the Committee will be presented for consideration at the next regularly scheduled Lake County Commissioners meeting. Final determination of all loans will be at the discretion of the Board of Commissioners.
- Loans will take approximately 45 days to process and fund.
