## OHA Update

COVID-19 has claimed three more lives in Oregon, raising the state's death toll to eight, the Oregon Health Authority reported at 8 a.m. today.

Oregon Health Authority also reported 18 new cases of COVID-19, bringing the state total to 209, as of 8 a.m. today. The COVID-19 cases reported today are in the following counties: Clackamas (3), Clatsop (1), Jackson (1), Marion (2), Multnomah (4), and Washington (7). Oregon's sixth COVID-19 death is a 78-year-old man in Clackamas County, who tested positive on March 15, and died March 22 at Kaiser Sunnyside Medical Center. He had underlying medical conditions.

Oregon's seventh COVID-19 death is a 63-year-old man in Multnomah County, who had underlying medical conditions and was not hospitalized at the time of death. He tested positive on March 16, and died March 23.

Oregon's eighth COVID-19 death is a 90-year-old woman in Washington County, who tested positive on March 19, and died March 23 at Providence St. Vincent Medical Center. She had underlying medical conditions.

### Special Transportation

- We are implementing best practices regarding disinfecting vehicles and keeping down the virus spread.
- We have implemented reductions March 17 until April 1 with only essential trips and staff.
- We are limiting numbers of people in the vehicles to comply with social distancing and attempting to limit shared rides all together.
- Masks, gloves and sanitizer are available to each driver.
- All employees are screened daily for any health changes.
- Several drivers fall into vulnerable categories and we have provided direction that any employees in those categories stay home.
- Vehicles have a notice posted for passengers that if they have had a fever, cough or shortness of breath to please use the surgical mask for preventive measures and the anti-bacterial hand sanitizer.
- Some supplies are being picked up and delivered for clients instead of them taking the bus.
- We have closed our building to the public and canceled all group gatherings at the center.
- Our kitchen staff of one continues to prepare home delivered meals and 'drive up' meals for the community.

## **Transportation Update**

### Oregon DMV

Under the Governor's March 23 "Stay Home, Save Lives" Executive Order, only six Oregon DMV offices will be open, by appointment only, for commercial driver knowledge tests and commercial driver license issuance beginning Wednesday, March 25.

Many DMV services remain available through OregonDMV.com and through the mail. With the exception of commercial driver knowledge tests and commercial driver license issuance, no other services will be available at DMV offices.

Limits on public access will be in effect until April 28, unless conditions allow DMV to open more offices sooner.
