OHA Update

Oregon reports two new COVID-19 deaths, 64 new COVID-19 cases

PORTLAND, Ore. — COVID-19 has claimed two more lives in Oregon, raising the state's death toll to 103, the Oregon Health Authority reported at 8 a.m. today.

Oregon Health Authority also reported 64 new cases of COVID-19 as of 8 a.m. today bringing the state total to 2,510. The new COVID-19 cases reported today are in the following counties: Benton (1), Clackamas (8), Coos (5), Deschutes (1), Klamath (1), Linn (4), Malheur (1), Marion (17), Multnomah (11), Umatilla (5), Washington (10).

Oregon's 102nd COVID-19 death is a 69-year-old man in Multnomah County, who tested positive April 7 and died on April 26 at Legacy Emanuel Hospital. He had underlying medical conditions.

Oregon's 103rd COVID-19 death is a 77-year-old man in Marion County, who tested positive April 25 and died on April 25 at his residence. He had underlying medical conditions.

County Update

The Lake County Board of Commissioners, Public Health Director, Public Health Officer, and OEM Director and several doctors in Lake County all approve of the Lake County Reopening Plan based on the Governor's Public Health Framework for Reopening Oregon. The plan was approved 4/30/2020 and will be available on the Lake County Joint Information Center Website.

The Lake County Board of Commissioners created and convened the Lake County Reopening Committee for the purpose of outlining a County plan for Phase 1, 2 and 3 of Reopening Oregon.

The Committee consisted of our Incident Commander, Public Health Director, Public Health Medical Officer, Emergency Manager, Medical Providers/Doctors and a County Commissioner.

Due to the ever-changing nature of our fluid situation, information associated with COVID-19 guidelines will be handled as an adaptive management plan and/or living document. This living document will likely be amended as new information becomes available or new requirements are needed. All parties involved have put countless hours into a plan to reopen Lake County and hope Phase One will begin soon. They believe this will protect public health will allowing for the economy to resume in phases.
